Membership Rights, Responsibilities and Privileges

Membership is a critical element to the success of the New Westminster Golf Course & Club. The course needs and values members who conduct themselves in a friendly and respectful manner while on course property, respect the course by filling divots and driving in designated areas on the course, and wearing proper golfing attire. However, outside play is also paramount to the course's success. We need our members to appreciate this fact and accommodate it especially during season. We value membership input and have created an Advisory Committee to facilitate membership communication. However, being a member does not allow participation in the management of the club.

Tee Times

- Members can book one tee time (4 players or less) 7 days in advance of the actual date. The tee time may not conflict with the tee
 times reserved for the Westminster Groups who reserve blocks of tee times throughout the year. During the season, which is
 defined as January 1 through April 15th, members will have one day advance booking privileges for tee times between 9:30 AM and
 1:00 PM.
- A member who does not show up for a booked tee time or does not cancel the tee time 24 hours before the scheduled date will be charged the non- member rate for each person that a member booked.
- In order to more effectively manage the workload in the Pro shop, we ask that members booking one tee time utilize the club's web site (https://westminster-golf.com) to book tee times.
- Many members play in groups which is defined as two or more tee times on a recurring basis. Each group will designate a group leader who will work with pro shop to determine the number of tee times that the group will need and establish time slots for the group. The pro shop will need to be aware of any non-members playing in the group so that they can be charged the appropriate rate. The group leader will be required to submit a list of players 48 hours prior to the scheduled play date. The club realizes that there can be changes in the 48-hour period prior to the scheduled tee times and expects the group leader to communicate those changes in a prompt manner. There will be no penalty for occasional last-minute cancelations. The club will work with the group leader to accommodate any underestimation of required tee times but not at the expense of fellow golfers who have scheduled tee times. If the group consistently overestimates required tee times, the club reserves the right to charge the group for the overestimation at the going non-member rate. The group will receive ample warning before any charges are incurred. The group leader will be responsible for coordinating the collection of the money and reimbursing the club.

Benefits

- Member will receive a 10 % discount on all items sold in the Pro shop.
- Members will receive a 50 % discount on range balls.
- Members will receive 50% discount on fees required to participate in the GHIN handicap system if the member desires to use it to track their golf handicap.

Other Items`

- The club will allow a member to transfer his or her membership to another individual approved by the club. The transfer fee is \$300.
- A member will be able to participate in any club sponsored events such as member /guest tournaments, and holiday tournaments at
 no additional costs for golf. However, membership will not cover the cost of golf in events sponsored by other entities such as the
 American Cancer society Relay for Life Tournament.
- Membership issues related to catastrophic events will be handled on an individual basis or in a separate policy statement.
- Members are required to ride two per cart whenever possible to reduce wear and tear on the course except in situations where
 public or individual health are a concern. Members who refuse to comply with the two players per cart requirement will be charged
 a Trail fee (\$14.00 per round) for driving alone.

Members have the option of paying for their membership in two payments: 50% of the fee initially and another 52% at the mid-point of the membership. Any member using this option will be invoiced for the mid-point payment. Failure to make the mid-point payment will immediately terminate the membership.

Our goal is to provide a well-maintained golf course and a clean moderately priced restaurant that provides a good variety of dining choices for your enjoyment.
